OUR IMPACT

SINCE 2019, SCATI HAS PROVIDED 19,495 UNITS OF SERVICE (APPROXIMATELY 4,874 HOURS) TO 311 HUMAN TRAFFICKING SURVIVORS ON LONG ISLAND.

WE HAVE 14 ACTIVE COLLABORATIVE PARTNERS, WHO HAVE WORKED TOGETHER TO TRAIN 6,236 PROFESSIONALS AND PARTICIPATE IN 77 COMMUNITY OUTREACH EVENTS.

SCATI HAS WORKED TO ARREST OVER 50 INDIVIDUALS ON TRAFFICKING CHARGES, AND PROSECUTE 42 TRAFFICKERS.

SCATI HAS CREATED 3 PROFESSIONAL RESEARCH REPORTS ABOUT HUMAN TRAFFICKING IN SUFFOLK COUNTY, NY.

A LOOK BACK AT 2021

Crucial collaborations for change

We kicked off 2021 with multiple events and campaigns for Human Trafficking Awareness Month in January; participants included the Human Trafficking Investigations Unit of the Suffolk County Police Department; Empowerment Collaborative of Long Island (ECLI/VIBES), the Suffolk County Sheriff's Office, the Suffolk County District Attorney's Office, Axis Church, Northwell Health, and more. From statewide events to events at a local theater in Huntington, we educated professionals and the community about human trafficking. Additionally, 2021 marked the full first year of the Human Trafficking Survivor Advisory Board (SAB) for ECLI/VIBES; the first of its kind on Long Island. The SAB serves the community by coming together to embrace survivors and provide them with outlets designed to ensure safety and promote a healthy lifestyle as well as to educate professionals and community members about how to address human trafficking. In January ECLI/VIBES teamed up with New York Project Hope to provide COVID relief and support to local families.

In February, Suffolk County Department of Probation and SCATI partners provided an in-depth training for Emergency Medical Service providers. Additionally, the Honorable Judge Camacho and Laura Mullen, co-founder and president of the Human Trafficking Survivor Advisory Board for ECLI/VIBES participated in Northwell Health's International Symposium hosted by Dr. Santhosh Paulus.

March marked the exciting merge of ECLI and VIBES. The Empowerment Collaborative of Long Island (ECLI), a not-for-profit organization at the forefront of combatting human trafficking on Long Island, merged with the Victims Information Bureau of Suffolk, established in 1976 as a pioneer in the field of domestic violence awareness and intervention services for victims of rape and sexual assault, elder abuse, child sexual abuse, and human trafficking.

In April, we published our SCATI Resource Guide with a general and local version and SCATI Human Trafficking Information Sheet and SCATI Brochure in English and Spanish. These can all be accessed and shared here: <https://tinyurl.com/3z7xf98d>

May made way for ECPAT-USA's Solidarity Ride. ECPAT-USA is the nation's leading anti-child trafficking organization seeking to end the commercial sexual exploitation of children through awareness, advocacy, policy, and legislation. The Suffolk County Sheriff's Office hosted the event at the finish line. SCATI members and supporters included ECLI/VIBES and the Survivor Advisory Board, Brentwood Union Free School District, and Northwell Health's HEART Program.

In July we (finally) revived in-person meetings with the modern flair of including our virtual attendees too and held our SCATI task force meeting face to face at SCPD headquarters; we then held our meeting at the Suffolk County Sheriff's Office and our last in person meeting of 2021 was at ECLI/VIBES where visitors took the grand tour of the new and expanded home of the now merged ECLI/VIBES. No meeting was without baked treats and hot drinks but most importantly bright smiles for thrilled SCATI members meeting in person (many for the first time).

September marked the Inaugural SCATI Memorial Service. This somber and heartfelt event reminded us all of the important work that we do and the strength of the individuals who are no longer with us but will always be in our hearts. Speakers included Acting Commissioner Stuart Cameron, Sheriff Errol D. Toulon Jr., District Attorney Tim Sini, Detective Sergeant James P. Murphy, Reverend Kara Bocchino, Honorable Fernando Camacho, Correction Officer Investigator Kellie Burghardt, El Schneider, Laura Mullen, family members of loved ones, and Alma Leticia. Additionally, Cycling For Change hosted their 5th Annual Golf Outing at the Muttontown Club.

On October 2, the Human Trafficking SAB for ECLI/VIBES joined Cycling For Change's 6th Annual Hope Walk/Ride to raise awareness about human trafficking. Together c4c, the SAB, SCATI, the Suffolk County Police Department, the Nassau County Police Department, the Suffolk County Sheriff's Office, Clean Slate Living, and the community brought hope and inspiration to support anti-human trafficking efforts on Long Island. #iHateTraffick. Detective Sergeant James P. Murphy and Molly England journeyed to the big apple to speak at the talk back for Mary Goggin's award-winning show *Runaway Princess*. This was their encore event after the first show and talk back in January of 2021 held virtually by Cinema Arts Centre in Huntington.

In November, Governor Kathy Hochul signed legislation S.674/A.459, the START (Survivors of Trafficking Attaining Relief Together) Act. After years of advocacy work, NY is once again a leader in legislation that supports and strengthens protections for victims of labor and sex trafficking who are convicted of a range of offenses as a result of that trafficking.

Throughout the year SCATI trainings spanned audiences including attendees from the Office of Mental Health, Housing and Urban Development, Stony Brook and Long Island University, Suffolk County Community College, New York State educators, faith-based organizations, substance use treatment facilities, pregnancy and healthcare centers, local scout troops, parents and children, the courts, victim service providers, youth advocacy organizations, and more!

We look forward to the year ahead; a year filled with love, community, hope, and empowerment.
